

Legend Trail Ladies Club Board Meeting Minutes

November 11, 2025

The meeting was called to order at 3 p.m. in the LT Cantina by Mary Ellen Nichols. Other board members in attendance were Jan Anderson, Lynn Wampler, Lynn Curtis, Laura Fulton and Cheryl Orrico.

Mary Ellen reported that the Website has been updated with new photobook and roster. She explained that we have one user credential who has access to make changes to the website. She also said that Wendy Cardinali is our new liaison in the Pro Shop.

The Board voted and ratified the increase in membership to 110. ME will send out job description updates to the Board.

Regarding member requests, we discussed players walking instead of riding in a golf cart. It was decided that if they keep up pace of play, this would not be a problem. As to the sand in the wash on #17, it was decided that if a player's ball was up against the sand or it interferes with a player's swing, they may take a drop within one club length without penalty, no closer to the hole, but they must stay in the wash. This is temporary until the issue is resolved.

The Board discussed having a fund raiser tournament in February. ME and Cheryl will follow through on ideas. Also discussed a possible happy hour but tabled that until after the holidays.

Cheryl Orrico's reviewed the Season Opener. She was given mostly positive comments. She discussed the Mid-season Ryder Cup which will be on January 21, 2026. Teams will be Red and Blue. She will look into the options for lunch following the Tournament.

Laura Fulton discussed the communication regarding players canceling. She will text the Board when someone cancels after the deadline. She reported that 19 members requested early tee times. She also said that she is working to place new members with Board members.

Lynn Curtis reported that we have 106 members. There are 19 on the waitlist for next season. She received one request for a waiver from Jan Anderson. The Board voted and passed the waiver.

Lynn Wampler said the status of the bank account and budget is in good shape. She has given the pro shop the loyalty card payments and will turn over the AGA payments in December. She explained that money was saved from the Season Opener mainly from

decorations. Lynn reported that she has collected one payment for cancellation fees. She is keeping track of all weekly proxy winners which will be paid at the end of the year. Trish Kelly, who is training as Treasurer, will be filling in for Lynn during the Mid-Season event as she will be out of town.

Mary Ellen reported in place of Julie Jenkins, who could not attend the meeting. Julie will send the information regarding State Medallion signup, which ME will send to the league. Qualifying dates are January 7, January 28, February 25 and March 25. Roy Jasinski and Lynn Curtis will register for the State Medallion Tournament which will be held either January 10th or 11th. ME will bring the "Good Luck" sign on January 7th league day. Roy and Lynn will be paired together near the end of the lineup that day.

A discussion was held regarding modifying handicaps for members.

Jan Anderson explained the process for communicating the Minutes which she sends to the Board for edit or approval. The Board will submit any changes within one day. The final minutes will be sent to the Board and sent in PDF form to Diana Woodward for placement on the Website.

Jan requested the Board review the Match Play General Information and Rules. There were a couple of changes including the entry fee which will be \$50 per team. Snacks and drinks after the final day of Match Play will be discussed further at the next Board meeting.

The meeting was adjourned at 4:30.
